The goal of the colloquium, which marked the 70th birthday of Knut Ipsen, was to find operable solutions for problems and challenges that confront the contemporary law of armed conflict.

Democracy in Turkey Ali Resul Usul, 2010-09-13 This book examines the impact of European political conditionality on the process of democratization in Turkey over a twenty year period. Employing theoretical and conceptual approaches to the issue of EU conditionality, the author compares the case of Turkey to that of other European nations. Arguing that Turkey became vulnerable to the European conditionality when it applied for membership in 1987, he shows how the political reforms demanded of Turkey were not fully carried out as the EU had not in essence accepted Turkey as an official candidate during this period. The EU has started to exert real 'active leverage' since Turkey was declared an official candidate in 1999, and the author explores how these conditions have exerted a positive influence on democratic consolidation in Turkey. However, its effectiveness in this regard has diminished to a significant extent due to a number of problems that have continued to remain central in EU-Turkey relations. This comprehensive analysis of Turkey-EU political relations and democratization places the case of Turkey within an international context. As such, it will be of interest not only to those studying Turkish politics, government and democracy, but anyone working in the area of international relations and the EU.

Overcriminalization Douglas Husak, 2008-01-08 The United States today suffers from too much criminal law and too much punishment. Husak describes the phenomena in some detail and explores their relation, and why these trends produce massive injustice. His primary goal is to defend a set of constraints that limit the authority of states to enact and enforce penal offenses. The book urges the weight and relevance of this topic in the real world, and notes that most Anglo-American legal philosophers have neglected it. Husak's secondary goal is to situate this endeavor in criminal theory as traditionally construed. He argues that many of the resources to reduce the size and scope of the criminal law can be derived from within the criminal law itself-even though these resources have not been used explicitly for this purpose. Additional constraints emerge from a political view about the conditions under which important rights such as the right implicated by punishment-may be infringed. When conjoined, these constraints produce what Husak calls a minimalist theory of criminal liability.

Husak applies these constraints to a handful of examples-most notably, to the justifiability of drug proscriptions.

It also looks at alternative ways forward toward democratized, land justice, based on redistributive policies and cooperative ownership models. From there, it moves into a collectively-authored section on Black Agrarianism, which details the long history of land dispossession among Black farmers in the southeastern US, as well as the creative acts of resistance they have used to acquire land and collectively farm it. The next section, on gender, explores structural and cultural discrimination against women landowners in the Midwest and also the role of “womanism” in land-based struggles. Next, a section on the cross-border implications of land enclosures and consolidations includes a consideration of what land justice could mean for farm workers in the US, followed by an essay on the challenges facing young and aspiring farmers. Finally, the book explores the urban dimensions of land justice and their implications for locally-autonomous food systems, and lessons from previous struggles for democratized land access. Ultimately, the book makes the case that to move forward to a more equitable, just, sustainable, and sovereign agriculture system, the various strands of the food movement must come together for land justice.

Democratization in Morocco Lise Storm, 2007-10-29 This book explores the political games of the Moroccan democratization process in the period from independence in 1956 until 2006.
